JURISDICTION

This Administrative Citation is issued pursuant to authority vested in the Illinois Environmental Protection Agency by 415 ILCS 5/1 et.seq., specifically 415 ILCS 5/31.1.

FACTS

- The Respondent, Radine Paper, is the present owner in control and possession of a facility located in the County of Jackson, State of Illinois.
- The facility is an open dump, operating without an Illinois Environmental
 Protection Agency Operating Permit, and designated with the Site Code #077 810

 The facility is known to the Agency as the Murphysboro/Radine Paper,
 Jackson County, Illinois site.
- The Respondent has owned, controlled and/or operated the facility at all relevant times hereto.
- 4. On August 8, 2016 Don Terry, Field Inspector, Jackson County Health

Department, inspected the facility. A true and correct copy of the inspection report, along with Mr. Terry's affidavit, are attached and incorporated herein by reference as Exhibit A.

VIOLATIONS

On the basis of Field Inspector, Don Terry's, direct observation, he has determined that the Respondent has caused or allowed open dumping at the above described facility in a manner that resulted in the following violation:

That on August 8, 2016, an on-site inspection of the facility disclosed the following:

The Respondent has caused or allowed litter at the facility in violation of 415 ILCS 5/21(p)(1).

CIVIL PENALTY

Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5), Respondent is subject to civil penalty of One Thousand Five Hundred Dollars (\$1,500) for the violation identified above, for a total of <u>OneThousand Five Hundred Dollars (\$1,500)</u>. If Respondent elects not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than October 15, 2016, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondent elects to contest the Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 and if the Illinois Pollution Control Board issues a finding of violation as alleged

herein, after an adjudicatory hearing, Respondent shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the One Thousand Five Hundred (\$1,500) statutory civil penalty for each violation.

Pursuant to Section 31.1 (d)(1) of the Act, 415 ILCS 5/31.1(d)(1), if Respondent fails to petition or elects not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, checks shall be made payable in equal amounts (50% of total penalty each) to:

- County of Jackson, c/o Jackson County Treasurer, Jackson County
 Courthouse, Murphysboro, Illinois, 62966; and
- (2) Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276.

Respondent shall complete and return the enclosed Remittance Forms with payments to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs

shall be assessed against the Respondent from the date payment is due up to and including the date that payment is received. The Complainant may either initiate proceedings against Respondent in Circuit Court or other debt collection actions to collect said penalty and/or hearing costs, plus any other interest accrued.

PROCEDURE FOR CONTESTING ADMINISTRATIVE CITATION

You have the right to contest this Citation, pursuant to 415 ILCS 5/31.1. If you elect to contest this Citation, you must file a Petition for Review with the Clerk of the Illinois Pollution Control Board. A copy of the Petition for Review shall also be filed with Rebecca Blomer, Assistant State's Attorney, Jackson County Courthouse, Third Floor, Murphysboro, Illinois 62966. YOUR PETITION FOR REVIEW MUST BE FILED WITHIN 35 DAYS OF THE DATE OF SERVICE OF THE PRESENT CITATION ON YOU. YOUR PETITION MUST STATE THE REASON(S) YOU BELIEVE THE PRESENT MATTER SHOULD NOT BE ISSUED. IF YOU FAIL TO FILE YOUR PETITION AND STATE THE REASONS THE PRESENT MATTER SHOULD NOT BE ISSUED, A DEFAULT ORDER AGAINST YOU WILL BE ENTERED BY THE POLLUTION CONTROL BOARD.

GENERAL REMARKS

NOTE: On January 2, 2007, an inspection was conducted of this site on the basis of a complaint (2007-012). During the inspection waste that was disposed by open dumping and open burning was observed. The inspection led to the issuing of Violation Notice L-2007—JC 146 to the site owner, Radine Paper. Then on June 2, 2011 another inspection was conducted of the site following a complaint (2011-100) received by the Jackson County Health Department (JCHD). The inspection led to the issuing of an Administrative Citation Warning Notice to Radine Paper and Dan Sronce, the site operator. After both notices were sent, the site was cleaned up and returned to compliance.

Also records obtained from the Jackson County Assessor's Office indicate that the site is currently owned by Radine Paper [Attachment: Page 1].

During the stated date and time, I conducted an inspection of the site listed above. This inspection was made as a follow up to a complaint received by the Jackson County Health Department. Complainant stated that a large pile of furniture and mattresses was sitting at the north end of Paper Lane. Weather conditions at the time of the inspection were: Partly cloudy with moderate winds and a temperature of approximately 89°F. I was accompanied on this inspection by Steve Williams of the Jackson County Health Department.

I arrived at the site and observed from Paper Lane a pile of mattresses at the edge of a wooded area (Photo #1, Site Sketch). This is the same area where I had observed open dumped waste during previous inspections (see notes above).

I walked to the area and observed a pile of waste mattresses and waste upholstered furniture lying next to a wooded area (Photos #2 - #6, Site Sketch). At the time of the inspection, the items listed as waste were not in use, were not useable in their current condition, and were not stored in such a way as to protect any future use.




