- I am employed by the Illinois Environmental Protection Agency ("Illinois EPA"), as Assistant Counsel for the Bureau of Land.
- 2. As part of my duties, I am responsible for the preparation of Administrative Citations issued by the Illinois EPA and the negotiation and litigation of appeals filed pursuant to such Administrative Citations. As part of my job experience, I have also submitted travel vouchers for reimbursement.
- 3. I have reviewed the Illinois EPA Division of Legal Counsel File 344-15-AC, which relates to AC 16-7, *Illinois EPA v. James Reichert Limited Family Partnership*, for the purpose of determining the costs expended by Illinois EPA.
- 4. I was the Illinois EPA attorney assigned to handle the hearing for AC 16-7, which was held in Marion. I was required to travel from Springfield to Marion and back. The Illinois Department of Transportation map of the State of Illinois indicates that the distance between Springfield and Mt. Carmel is 186 miles. Based on my own job experience, I am aware that the approved mileage reimbursement rate in June 2016 was \$.54 per mile.
