

HEARING OFFICER ORDER

On November 7, 2016, respondent Midwest Generation filed pursuant to Section 101.604 of the Board's procedural rules, "Proposed Corrections to Transcript of October 5, 2016 Hearing". *Via* e-mail on November 10, 2016, the respondent Illinois Environmental Protection Agency stated that it will not file a response. IT IS SO ORDERED.




