

HEARING OFFICER ORDER

On November 15, 2016, all parties participated in a telephonic status conference with the hearing officer. The respondent stated that the permit has been noticed for the required public comment that ends November 26, 2016. The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including May 4, 2017.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on January 19, 2017, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a motion to withdraw this appeal is filed prior to the next status conference, the conference will be cancelled without further notice.

IT IS SO ORDERED.




