HEARING OFFICER ORDER

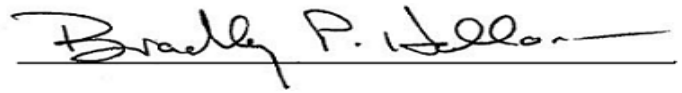
On December 7, 2016, the petitioner filed its second motion to stay proceedings with a status report. (Mot.). It is noted that the initial stay was granted by the Board on September 8, 2016.

In the motion, petitioner states that the results of the first round of sampling in August 2016 are promising. A second round of sampling was scheduled for November 2016, but the petitioner does not yet have the results. Mot. at 3. Petitioner states that when the second round results are received, it intends to file an amended petition which will seek appropriate remedial setback relief. *Id.* During the telephonic status conference on December 1, 2016, the respondent Illinois Environmental Protection Agency stated that it had no objection to petitioner's motion to stay.

Petitioner's motion is granted and the proceedings are stayed until January 6, 2017.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on January 5, 2017, at 10:30 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing

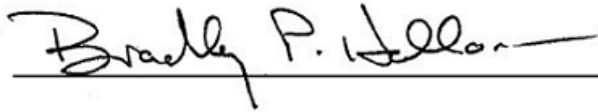
