This hearing is being held for the purpose of satisfying US EPA SIP requirements that the state hold a hearing on any SIP revision. The Board is holding the hearing for the purpose of fulfilling that federal requirement so that the agency doesn't later have to separately do it.

During this time period, US EPA updated the -- or they designated additional methods for ambient air quality monitoring. The Board proposed amendments on October 27th that would incorporate those newly designated methods by reference. There were no other amendments proposed to the rules.
