
**HEARING OFFICER ORDER**

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including July 6, 2017.

At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




