## MOTION FOR EXTENSION OF TIME TO FILE ADMINISTRATIVE RECORD

NOW COMES the Respondent, ILLINOIS ENVIRONMENTAL PROTECTION

AGENCY, by and through its attorney, Special Assistant Attorney General Scott B. Sievers, and, pursuant to 35 Ill. Adm. Code 105.116(a), for Respondent's Motion for Extension of Time to File Administrative Record states the following:

- 1. On June 8, 2017, this honorable Board ordered the Respondent to "file the entire record of its determination by July 5, 2017."
- 2. The process of compiling the administrative record requires staff within Illinois EPA's Leaking Underground Storage Tank section to search for the requisite documentation, organize it chronologically, then provide it to the Division of Legal Counsel for formatting for filing. This includes the preparation of the Certificate of Record on Appeal. Before this certificate is filed, a draft is sent to the LUST section project manager to review alongside the compiled administrative record. If it then meets with his approval, formatting of the administrative record is finalized, the project manager signs the certificate, and the certificate is filed with the Board along with the administrative record.

record so as to allow it to be finalized and filed in compliance with the Board's Order.

4. To allow for the additional time necessary for the project manager to return from

vacation and assist in the preparation of the administrative record, the Respondent seeks a

twenty-one (21) day extension of the time to file the administrative record in this action.

5. Counsel for the Respondent has conferred with counsel for the Petitioner, and counsel

for the Petitioner has no objection to this motion.

WHEREFORE, the Respondent, ILLINOIS ENVIRONMENTAL PROTECTION

AGENCY, prays that the honorable Hearing Officer ALLOW the Respondent's MOTION FOR

EXTENSION OF TIME TO FILE ADMINISTRATIVE RECORD and extend the time for the

Respondent to file the administrative record in this action by twenty-one (21) days.
