ORDER OF THE BOARD (by G.M. Keenan):

On April 9, 2013, Ameren Energy Resources (Ameren) proposed rules for the closure of coal combustion waste (CCW) surface impoundments at eight coal-fired power plants. On October 28, 2013, the Illinois Environmental Protection Agency (IEPA) proposed generally applicable rules concerning CCW in docket R14-10. Ameren requested a stay of this site-specific rulemaking to evaluate a draft version of what became IEPA's proposal and determine whether it satisfactorily addressed its facilities. The Board granted the stay, which lasted through August 2, 2017. <u>Site-Specific Rule for the Closure of Ameren Energy Resources Ash Ponds:</u> Proposed New 35 Ill. Adm. Code 840, Subpart B, R13-19, slip op. at 2 (July 25, 2013); slip op. at 1 (Feb. 2, 2017).

On August 2, 2017, Illinois Power Resources, LLC (IPR) and AmerenEnergy Medina Valley Cogen, LLC (Medina Valley)¹ filed a motion to withdraw their site-specific proposal. IPR and Medina Valley stated that several developments support withdrawal: an open Board rulemaking concerning CCW (R14-10); federal rules addressing coal combustion residuals (40 C.F.R. 257); and the recent Water Infrastructure Improvements for the Nation (WIIN) Act, which authorizes state programs to operate in place of the federal rules (P.L. No. 114-322; *see* 42 U.S.C. § 6945(d)). The Board has not received any response to the motion. The Board grants the motion to withdraw the rulemaking proposal and closes this docket.
