#### **MOTION FOR VOLUNTARY DISMISSAL**

Prairie Rivers Network ("PRN") and Sierra Club hereby move to voluntarily dismiss the Petition filed in the above-captioned matter. In support of this motion, PRN and Sierra Club state as follows:

- 1. On April 15, 2010, the Board granted PRN's and Sierra Club's Motion to Intervene in PCB 10-61 and accepted for filing PRN and Sierra Club's Complaint in PCB 11-02. In the Complaint, PRN and Sierra Club alleged that NPDES Permit # IL0061247 violated Section 12(a) and (f) of the Act, 415 ILCS 5/12(a) and (f).
- On April 26, 2013, Illinois Environmental Protection Agency reissued NPDES
   Permit # IL0061247.
- 3. On June 13, 2013, PRN and Sierra Club filed an Amended Petition for Administrative Review of NPDES Permit # IL0061247 in the above-captioned matter.
- 4. From August 20, 2013 onward, the above-captioned matter has been on hold pending resolution of PCB 10-61 and 11-02.

- 5. On June 28, 2017, the parties reached a settlement on all outstanding issues in PCB 10-61 and 11-02, as well as the above-captioned permit appeal.
- 6. On August 17, 2017, the Board accepted and finalized the parties' settlement in PCB 10-61 and 11-02.
- 7. Accordingly, PRN and Sierra Club respectfully move to voluntarily dismiss this Petition before the Board.
