### **HEARING OFFICER ORDER**

On October 16, 2017, complainant's representative, Mr. David Miller, and respondent participated in a telephone status conference with the hearing officer. This matter is resolved, and the parties agreed to file a joint motion to dismiss. To date, Mr. David Miller is the only complainant to return his signature page to respondent's attorney. According to Mr. Miller, the other complainants do not object to the motion to dismiss, but appear to be unwilling to return their signature.

In the Hearing Officer Order dated September 6, 2017, complainants were instructed to return their signature to respondent's attorney by September 30, 2017, or contact the hearing officer if they were unable or unwilling to do so. No complainants contacted the hearing officer.

The hearing officer will contact the parties on November 13, 2017 if the motion to dismiss has not been filed.
