**MIDWEST GENERATION, LLC’S MOTION TO CORRECT
THE OCTOBER 26, 2017 (AFTERNOON SESSION) HEARING TRANSCRIPT**

Pursuant to 35 Ill. Adm. Code 101.604, Respondent Midwest Generation, LLC (“MWG”), by its undersigned counsel, submits to the Hearing Officer this motion to correct the transcript for the October 26, 2017 (afternoon session) hearing date and states as follows:

- 1) On November 3, 2017, the transcript for the afternoon session of the fourth day of the hearing for the above captioned matter (October 26, 2017 (afternoon session)) was filed with the Illinois Pollution Control Board (“Board”) Clerk’s Office.
- 2) Pursuant to 35 Ill. Adm. Code 101.604, a party has 21 days from the date the transcript is filed with the Clerk’s Office to file a motion with the Hearing Officer to correct the transcript. Pursuant to 35 Ill. Adm. Code 101.300(a), the computation of time runs until the close of the last business day, or the next business day if the last day is a State legal holiday. Twenty-one days from November 3, 2017 was November 24, 2017, a State legal holiday. Thus, this motion is timely filed on the first business day after November 24, 2017.

3) On November 22, 2017, Complainants filed a Motion to Correct the October 26, 2017 Hearing Transcript.¹ MWG will file a response to Complainants' motion on or before December 6, 2017. Additionally, MWG has noted the following typographical errors in the October 26, 2017 (afternoon session) hearing transcript and requests that the Hearing Officer make the following corrections:
