RECOMMENDATION OF THE ILLINOIS ENVIRONMENTAL PROTECTION AGENCY

The Illinois Environmental Protection Agency (Illinois EPA) hereby files its Recommendation pursuant to Section 125.204(a) of the regulations of the Illinois Pollution Control Board (the Board), 35 Ill. Adm. Code 125.204(a).

 On April 11, 2017, the Illinois EPA received a request from Keith Morby Finishing Barns (log number TC-137871, Exhibit A) for an Illinois EPA recommendation regarding the tax certification of water pollution control facilities pursuant to Section 125.204(a) of the Board's regulations, 35 Ill. Adm. Code 125.204(a).

2. The facility's address is:

3. The proposed water pollution control facilities in this request are located at Section 14, T13N, R3W of the 4th P.M. in Mercer County, at the above street address and consist of the following:

Livestock waste management facilities consisting of: a concrete pit (approximately 391 ft. x 52 ft. x 8 ft. deep) with ten concrete pump outs (approximately 6 ft. x 6 ft. x 8 ft. deep); a PVC perimeter tile drain (4 in. diameter and approximately 500 ft. in length); and slotted floors over the pit.

- 4 These livestock waste management facilities are used to collect, transport and/or store livestock wastes prior to cropland application, and are further described in Exhibit A.
- Section 11-10 of the Property Tax Code, 35 ILCS 200/11-10 (2014), and Section
 125.200(a)(1) of the Board's regulations, 35 Ill. Adm. Code 125.200(a)(1), define
 pollution control facilities as:

[A]ny system, method, construction, device or appliance appurtenant thereto or any portion of any building or equipment, that is designed, constructed, installed or operated for the primary purpose of: eliminating, preventing, or reducing air or water pollution, as the terms air pollution and water pollution are defined in the Act; or treating, pretreating, modifying or disposing of any potential solid, liquid or gaseous pollutant which if released without treatment, pretreatment, modification or disposal might be harmful, detrimental or offensive to human, plant or animal life, or to property.

- 6. If it is found that the claimed facility or relevant portion thereof is a pollution control facility as defined in Section 125.200(a)(1) of the Board's regulations,
 35 Ill. Adm. Code 125.200(a)(1), the Board has the authority to enter a finding and issue a certificate to that effect, pursuant to Section 11-20 of the Property Tax Code, 35 ILCS 200/11-20 (2014) and Section 125.216 of the Board's regulations,
 35 Ill. Adm. Code 125.216.
- Pursuant to Section 125.204(a) of the Board's regulations, 35 Ill. Adm. Code
 125.204(a), if the Illinois EPA receives a tax certification application it must file a recommendation on the application with the Board.
- 8. Based on the information in the application and the purpose of the facilities, it is the Illinois EPA's engineering judgment that the described facilities may be considered pollution control facilities, with the primary purpose of eliminating,

These livestock waste management facilities are used to collect, transport, and/or store livestock waste prior to cropland application.

These facilities are further described in the enclosed applications and supporting documents.

Based on the information included in this submittal, it is our engineering judgment that the above proposed facilities may be considered "Pollution Control Facilities" under 35 IAC 125.200(a), with the primary purpose of eliminating, preventing, or reducing water pollution, or as otherwise provided in this section, and therefore eligible for tax certification from the Illinois Pollution Control Board. 

Willett, Hofmann & Associates, Inc. has reviewed structural design calculations for precast hog slats and precast beams at the Keith Morby Hog Facility near Aledo, Illinois. The purpose of this letter is to provide certification for precast concrete components as required by the Illinois Department of Agriculture (IDOA).

This design is limited to the precast concrete slats and beams as a component design for this project only. Responsibility for the overall building structural integrity is not included and shall be provided by others.

Based on the information you provided, we understand the beams have a 12'-0" span length. We understand that cross sections are 10" deep with a varying width ranging from 9" at the top to 8" at the bottom. The slats are 4'-0" wide x 10'-0" long x 4" thick. The beams are reinforced with three (3) #6 reinforcing bars placed 1 $\frac{1}{2}$ " clear from the bottom and two (2) #3 reinforcing bars placed 1 $\frac{1}{2}$ " from the top. The slats are reinforced with one (1) 3/8" diameter deformed wire on the bottom and one (1) 5/16" diameter deformed wire on the top in each slat. Clear distances for slat reinforcing are 1 $\frac{1}{2}$ " top and $\frac{3}{4}$ " bottom.

Our evaluation has been based upon compliance with the American Concrete Institute (ACI) Building Code Requirements for Reinforced Concrete. The slats have been evaluated for loading prescribed in the Livestock Facilities Waste Handbook (MWPS-18), Third Edition, published by the Midwest Plan Service (MWPS). The following is a summary of the design criteria used in this evaluation.


