

HEARING OFFICER ORDER

On February 8, 2018, all parties participated in a telephonic status conference with the hearing officer. The petitioner it has proposed new language for the revised permit and the parties continue their discussions on how to resolve this consolidated appeal. There remains some permit conditions at issue and the parties are scheduling a meeting to discuss them. The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including August 9, 2018.

The parties or their legal representatives are reminded and directed to appear at a telephonic status conference with the hearing officer on March 29, 2018, at 9:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




