**MOTION TO EXTEND TIME TO FILE THE ILLINOIS ENVIRONMENTAL
PROTECTION AGENCY'S RECOMMENDATION**

NOW COMES the Illinois Environmental Protection Agency (Agency or Illinois EPA), by and through one of its attorneys, Sara G. Terranova, pursuant to 35 Ill. Adm. Code 101.500 and 101.522, requests that the Illinois Pollution Control Board (Board) grant Illinois EPA additional time to file its recommendation in the instant alternative thermal effluent limitations proceeding. In support of this motion, the Illinois EPA states as follows:

1. On January 29, 2018, the Illinois EPA requested a 30-day extension of time to file its recommendation to continue discussions with the Illinois Department of Natural Resources regarding Marathon Petroleum Company LP's (Marathon or Petitioner) alternative thermal effluent limitations petition.

2. On January 30, 2018, the Board granted the Agency's motion.

3. On February 27, 2018, Petitioner filed an Addendum to Technical Support Documentation for Alternative Thermal Effluent Limitations.

4. As indicated by the Petitioner, Marathon intended for this addendum to supplement the record by providing additional review and analysis of the potential for adverse

effects that might be posed by Marathon's requested alternative thermal effluent limitations. *See* Petitioner's Motion for Leave to File an Addendum to Exhibit 4 of the Petition to Approve Alternative Thermal Effluent Limitations at 4, Paragraph 14.

5. To ensure a complete and proper review of the Petitioner's addendum, the Agency is requesting an additional 45 days after the filing of the addendum, to file its recommendation.

6. The Petitioner has indicated it has no objection to the Agency's motion for extension of time to file its recommendation.

WHEREFORE, the Illinois EPA requests the Board grant the Agency 45 days after the filing of the addendum (Friday, April 13, 2018), to file its recommendation.
