JURISDICTION

This Administrative Citation is issued pursuant to the authority vested in the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act, 415 ILCS 5/31.1 (2016).

FACTS

- 1. That Michael Crank (Respondent) is the present owner and operator of a facility located at 490 Zola Road, Harrisburg, Saline County, Illinois. The property is commonly known to the Illinois Environmental Protection Agency as Harrisburg/Crank, Mike.
- That said facility is an open dump operating without an Illinois Environmental
 Protection Agency Operating Permit and is designated with Site Code No. 1658055011.
 - 3. That Respondent has operated said facility at all times pertinent hereto.
- 4. That on January 30, 2018, Phillip Pierce-Savoie of the Illinois Environmental Protection Agency's Marion Regional Office inspected the above-described facility. A copy of his

inspection report setting forth the results of said inspection is attached hereto and made a part hereof.

5. That on March 19, 2018 Minois EPA sent this Administrative Citation [via Certified

Mail No. 7012 0470 0001 3000 4199 (Vanic for hand delivery).

VIOLATIONS

Based upon direct observations made by Phillip Pierce-Savoie during the course of his January 30, 2018 inspection of the above-named facility, the Illinois Environmental Protection Agency has determined that Respondents have violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

- (1) That Respondents caused or allowed the open dumping of waste in a manner resulting in litter, a violation of Section 21(p)(1) of the Act, 415 ILCS 5/21(p)(1) (2016).
- (2) That Respondents caused or allowed the open dumping of waste in a manner resulting in open burning, a violation of Section 21(p)(3) of the Act, 415 ILCS 5/21(p)(3) (2016).
- (3) That Respondents caused or allowed the open dumping of waste in a manner resulting in deposition of general construction or demolition debris or clean construction or demolition debris, a violation of Section 21(p)(7) of the Act, 415 ILCS 5/21(p)(7) (2016).

CIVIL PENALTY

Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5) (2016), Respondents are

subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total of <u>Four Thousand Five Hundred Dollars (\$4,500.00)</u>. If Respondents elect not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than <u>May 7, 2018</u>, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondents elect to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 (2016), and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondents shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the One Thousand Five Hundred Dollar (\$1,500.00) statutory civil penalty for each violation.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1) (2016), if Respondents fail to petition or elects not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondents' check shall be made payable to the Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Along with payment, Respondents shall complete and return the enclosed Remittance Form to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondents from the date payment is due up to and including the date that payment is

received. The Office of the Illinois Attorney General may be requested to initiate proceedings against Respondents in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

Respondents have the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31/1 (2016). If Respondents elect to contest this Administrative Citation, then Respondents shall file a Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago, Illinois 60601. A copy of said Petition for Review shall be filed with the Illinois Environmental Protection Agency's Division of Legal Counsel at 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondents.

Executive Summary

This inspection was conducted as a follow-up to the March 9, 2017 open dumping complaint inspection conducted by this office. This facility is an open field, owned by Michael Crank, that is adjacent to a residential neighborhood where trade waste from a tree trimming and cutting service is accumulated. There is no residence at this site, and it has not been developed. Some of this material is being turned into firewood and woodchips, some of it is being open burned, and the rest is accumulating. During the previous inspection evidence of open burning of trade waste and open dumping of wastes, including but not limited to, General Construction and/or Demolition Debris (GC/DD) was observed. Continuing violations were observed.

Inspection Narrative

I arrived at the site at 10:15am. No one was present at the site, and no one approached this inspector during the inspection. This site is an open field adjacent to several residences. No improvements exist at this site, though a RV and an intermodal shipping crate have been brought on-site. It was ~27 F and

sunny, and the ground was muddy. I immediately observed several piles of General Construction and/or Demolition Debris (GC/DD) that had been open dumped here that were not present during the previous inspection. There were at least three accumulations, and the total amount of GC/DD present at this site was visually estimated to be at least 50 cu. yds. Other wastes, which included a white good and general refuse, were present, and were visually estimated to be approximately 20 cu. yds. in volume. These wastes were not observed during the previous inspection either. Approximately 300 cu. yds. of trade waste from the property owner's tree trimming and removal service was also present. Lumber splitting equipment and a small wood chipper was on site. Two accumulations of ash near the wood chipper and surrounded by trade waste was observed. One was a small pile, visually estimated to be 1 sq. yd. The other was visually estimated to be 8 cu. yds. Partially combusted trade waste (tree trunk sections) were also observed at the southeast side of the site, adjacent to a residential lawn. The inspection was concluded at or around 10:25am.

The Saline County Sheriff's Department issued citations for open burning against Mr. Crank on September 12, 2017, January 8, 2018 and January 13, 2018. Attached is a list of dates the Saline County Sheriff's Department received open burning complaints against Mr. Crank.






