Dear Pollution Control Board Chairman and Board Members,

The Illinois Environmental Protection Agency (IEPA) has proposed a drastic change to state air pollution rules that eliminates provisions which have greatly limited harmful emissions from approximately half the coal power plants in the state. The proposed change would allow a company that operates a collection of eight large coal plants to shut down its least polluting power plants, which do the least damage to public health, and to instead run their dirtiest plants more. This would increase emissions and sicken and threaten the lives of more Illinois residents.

The state should not be weakening its existing strong public health protections, nor should it incentivize a company to produce more power from its dirtiest and most damaging power plants at the expense of Illinois residents' health. Because of the threat this rule change poses to vulnerable populations in Illinois, such as children living with asthma and adults living with COPD who are most sensitive to and most affected by increases in air pollution, I strongly urge you to oppose this IEPA proposed rule that would only benefit a major polluter.
