ORDER OF THE BOARD (by B.K. Carter):

On March 19, 2018, the Illinois Environmental Protection Agency (Agency) timely filed an administrative citation against Michael Crank doing business as "Crank Tree Service" (Mr. Crank). *See* 415 ILCS 5/31.1(c) (2016); 35 Ill. Adm. Code 101.300(b), 108.202(c). The administrative citation concerns Mr. Crank's property located at 490 Zola Road in Harrisburg, Saline County. The property is commonly known to the Agency as the "Harrisburg/Crank, Mike" site and is designated with Site Code No. 1658055011. For the reasons below, the Board accepts Mr. Crank's petition to contest the administrative citation.

Under the Environmental Protection Act (Act) (415 ILCS 5 (2016)), an administrative citation is an expedited enforcement action brought before the Board seeking civil penalties that are fixed by statute. Administrative citations may be filed only by the Agency or, if the Agency has delegated the authority, by a unit of local government, and only for limited types of alleged violations. *See* 415 ILCS 5/21(o), 21(p), 22.51, 22.51a, 31.1(c), 42(b)(4), 42(b)(4-5), 55(k) (2016); 35 Ill. Adm. Code 108.

In this case, the Agency alleges that on January 30, 2018, Mr. Crank violated Sections 21(p)(1), (p)(3), and (p)(7) of the Act (415 ILCS 5/21(p)(1), (p)(3), (p)(7) (2016)) by causing or allowing the open dumping of waste in a manner resulting in litter, open burning, and the deposition of general or clean construction or demolition debris at the Saline County site. The Agency asks the Board to impose on Mr. Crank the statutory \$1,500 civil penalty for each alleged violation, for a total civil penalty of \$4,500.

As required, the Agency served the administrative citation on Mr. Crank within "60 days after the date of the observed violation." 415 ILCS 5/31.1(b) (2016); *see also* 35 Ill. Adm. Code 101.300(c), 108.202(b). Any petition to contest the administrative citation was due by April 30, 2018. On April 24, 2018, Mr. Crank timely filed a petition. *See* 415 ILCS 5/31.1(d) (2016); 35 Ill. Adm. Code 101.300(b), 108.204(b). Mr. Crank denies the alleged violations. *See* 35 Ill. Adm. Code 108.206.

The Board accepts the petition and directs the hearing officer to proceed expeditiously to hearing. The hearing officer will give the parties at least 21 days written notice of the hearing. See 35 Ill. Adm. Code 108.300; 415 ILCS 5/31.1(d)(2) (2016). Upon its own motion or the motion of any party, the Board or the hearing officer may order that the hearing be held by videoconference. In deciding whether to hold the hearing by videoconference, factors that the Board or the hearing officer will consider include cost-effectiveness, efficiency, facility accommodations, witness availability, public interest, the parties' preferences, and the proceeding's complexity and contentiousness. See 35 Ill. Adm. Code 101.600(b), 108.300(d).

By contesting the administrative citation, Mr. Crank may have to pay the hearing costs of the Board and the Agency. *See* 415 ILCS 5/42(b)(4-5) (2016); 35 Ill. Adm. Code 108.500. A schedule of the Board's hearing costs is available from the Clerk of the Board and on the Board's website at https://pcb.illinois.gov/. *See* 35 Ill. Adm. Code 108.504. Mr. Crank may withdraw his petition to contest the administrative citation at any time before the Board enters its final decision. If Mr. Crank chooses to withdraw his petition, he must do so in writing, unless he does so orally at hearing. *See* 35 Ill. Adm. Code 108.208. If Mr. Crank withdraws his petition after the hearing starts, the Board will require him to pay the hearing costs of the Board and the Agency. *See id.* at 108.500(c).

The Agency has the burden of proof at hearing. See 415 ILCS 5/31.1(d)(2) (2016); 35 III. Adm. Code 108.400. If the Board finds that Mr. Crank violated Sections 21(p)(1), (p)(3), and (p)(7) of the Act (415 ILCS 5/21(p)(1), (p)(3), (p)(7) (2016)), the Board will impose civil penalties on him. The civil penalty for violating any provision of Section 21(p) is \$1,500 for each violation, except that the penalty amount is \$3,000 for each violation that is the person's second or subsequent adjudicated violation of that provision. See 415 ILCS 5/42(b)(4-5) (2016); 35 III. Adm. Code 108.500(a). However, if the Board finds that Mr. Crank "has shown that the violation resulted from uncontrollable circumstances, the Board shall adopt a final order which makes no finding of violation and which imposes no penalty." 415 ILCS 5/31.1(d)(2) (2016); see also 35 III. Adm. Code 108.500(b).

IT IS SO ORDERED.
