JURISDICTION

This Administrative Citation is issued pursuant to the authority vested in the Macon County Environmental Management Department, a delegated county of the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act , 415 ILCS 5/31.1.

FACTS

- That Respondent, Gary Miller, is the land owner/operator of a property located at 3680 Stare Road, Oakley in Macon County, Illinois.
- That Respondent has owned and/or operated said property at all times pertinent hereto.
- 3. That from April 26, 2018 through May 10, 2018, Laurie Rasmus of the Macon County Environmental Management Department conducted an investigation concerning the

above-referenced facility. A copy of her report setting forth the results of said investigation is attached hereto and made a part hereof.

VIOLATIONS

Based upon direct findings made by Laurie Rasmus during the course of her investigation of the above-referenced facility, the Macon County Environmental Management Department has determined that Respondent violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

- (1) That Respondent caused or allowed open dumping of waste in a manner resulting in litter, a violation of Section 21(p)(1) of the Act, 415 ILCS 5/21(p)(1); and
- (2) That Respondent caused or allowed open dumping of waste in a manner resulting in open burning, a violation of Section 21(p)(3) of the Act, 415 ILCS 5/21(p)(3); and
- (3) That Respondent caused or allowed open dumping of waste in a manner resulting in deposition of General Construction or Demolition Debris as defined in Section 3.160(a), a violation of Section 21(p)(7) of the Act, 415 ILCS 5/21(p)(7).

CIVIL PENALTY

Pursuant to Section 42(b)(4) of the Act, 415 ILCS 5/42(b)(4), Respondent is subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total of Four Thousand Five Hundred Dollars (\$4,500). If Respondent elects not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than September 03, 2018, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondent elects to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1, and if the Illinois Pollution Control Board issues a finding of violation(s) as alleged herein, after an adjudicatory hearing, Respondent shall be assessed the associated hearing costs incurred by the Macon County Environmental Management Department and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the statutory civil penalty of Four Thousand Five Hundred Dollars (\$4,500.00).

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1), if Respondent fails to petition or elects not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and a finding of violation(s) as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondent's checks shall be made payable in equal amounts (50% of total penalty each) to:

(1) Macon County Environmental Management Department and mailed to the attention of Debra Hughes-Garrett, Macon County Environmental Management Department, 141 South Main Street, Room 408, Decatur, Illinois 62523.

(2) Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276.

Along with payments, Respondent shall complete and return the enclosed Remittance Forms to ensure proper documentation of payments.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be

assessed against the Respondent from the date payment is due up to and including the date that payment is received. The Office of the Macon County State's Attorney may be requested to initiate proceedings against Respondent in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

Respondent has the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1. If Respondent elects to contest this Administrative Citation, then Respondent shall file a signed Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago, Illinois 60601. A copy of said Petition for Review shall be filed with the Macon County State's Attorney at 253 East Wood Street, Decatur, Illinois 62523. Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondent.

Report Narrative

An investigation regarding this site was conducted from April 26, 2018 through May 10, 2018 by Laurie Rasmus (author of this report), representing the Macon County Environmental Management Department (MCEMD). The following persons were interviewed/communicated with:

Gary Miller, property owner

Delbert Powell, fire chief of the Cerro Gordo Fire Protection District (CGFPD) Tim Schoemperlen, assistant chief of the Cerro Gordo Fire Protection District Tim Stemple, lieutenant of the Cerro Gordo Fire Protection District

General Information/Site History/Property Ownership

This rural, residential property in the Oakley Township of Macon County of approximately ten acres is designated as Parcel # 14-08-35-100-016 (alternate Parcel # 08-35-100-016) and addressed as 3680 Stare Road, Oakley.

According to the Macon County Recorder's Office records, the property is owned by Gary S. and Tracy L. Miller.

This initial investigation was conducted after receiving a complaint on April 26, 2018, which alleged that waste items, including carpet, sofas and chairs, had been open burned at the site on the preceding night.

Investigation Findings

On April 27, 2018, I initiated a telephone conversation with Gary Miller. I first explained that a complaint had been received and described the nature of the complaint. I then stated that I wished to inspect the property that day at approximately 3:00 p.m. Mr. Miller said that he would not be there at that time. I then went on to explain that he didn't need to be present during the inspection but asked if he would be available at another time. Mr. Miller replied, "Stay off of my property" and "don't come out unless you have a warrant from the sheriff."

On May 03, 2017, Chief Powell returned my previous telephone call and we conversed about his department's involvement with the fire on the Miller property on April 25, 2018. Chief Powell said that observations had been made by CGFPD personnel and said, "It looked like he was burning tractor tires." I asked Chief Powell for a copy of the report that was made and he said that he would check into it.

On May 07, 2018, Chief Powell met with me in my office. He gave me copy of the report for his fire department's alarm and response to a fire on April 25, 2018 at the Miller property. (See attached Cerro Gordo Fire Alarm Log Sheet and second page). Chief Powell said that he was not at the site on April 25, 2018 but that the report was written by Assistant Chief Brian Schoemperlen.

Later on May 07, 2018 I initiated a telephone call with Assistant Chief Schoemperlen, who reported that he himself was on site but not at the exact location in which he could directly observe the fire but that Lt. Tim Stemple had observed the fire. I asked Assistant Chief Schoemperlen to have Lt. Stemple send me his observations in an email. I asked Assistant Chief Schoemperlen if he was sure if the address noted as the location on the report was accurate. He said that he would check into it.

On May 08, 2018, Assistant Chief Schoemperlen initiated a telephone conversation with me. He said that the address for the Miller property in regards to the April 25, 2018 fire was 3682 Stare Road.

On May 10, 2018, Lt. Tim Stemple met with me in my office. He asked me if I had received his email message and I said that I had not. Lt. Stemple then found the message on his phone and we were able to see that there was an error in my email address. He then read the message of the email aloud to me. From his phone, he then forwarded me the email message to my correct email address (see attached mail, dated May 08, 2018 and forwarded May 10, 2018). I asked Lt. Stemple if he actually saw the waste items, such as the couch and tire, that he had listed in the email and he said, "Yes." We then discussed the location of the fire on the Miller property during the night of April 25, 2018. I showed Lt. Stemple an aerial view that I had printed from the County's 2016 aerial imagery and asked him to mark the print where the fire had occurred (see attached aerial photo). Using a silver colored marker, Lt. Stemple first made a dot and then an "X" on the print. The marked "X" was on the eastern section of parcel 08-35-100-016 that, according to Macon County's records, is addressed as 3680 Stare Road and owned by Gary and Tracy Miller. I asked him if he would be willing to sign and date the print as part of his testimony and he did so with a pen. Lt. Stemple also signed on the printed copy of his email message (see attached mail, dated May 08, 2018 and forwarded May 10, 2018) and on an affidavit that was then notarized (see attached Affidavit).

Summary of Apparent Violations

Environmental Protection Act 415 ILCS 5/1 et seq. (formerly III Rev. Stat. Ch. 111 ½, 1001 et seq.) {hereinafter referred to as the "Act"} and **35 Illinois Administrative Code**. (Title 35: Environmental Protection, Subtitle G: Land Pollution, Chapter I: Pollution Control Board) [Regulations]

Pursuant to Section 9(a) of the Act, no person shall cause, threaten, or allow; or tend to cause, threaten or allow, air pollution in Illinois.

A violation of Section 9(a) is alleged because evidence of open-burning that would cause, threaten, or allow; or tend to cause, threaten, or allow air pollution

in the State of Illinois was reportedly observed by fire department personnel during firefighting activities.

Pursuant to Section 9(c) of the Act, no person shall cause or allow the open burning of any refuse, conduct any salvage operation by open burning or cause or allow the burning of any refuse in any chamber not specifically designed for the purpose and not approved by the agency.

A violation of Section 9(c) is alleged because evidence that open burning of refuse occurred on site was reportedly observed by fire department personnel during firefighting activities.

Pursuant to Section 21(a) of the Act, no person shall cause or allow the open dumping of any waste.

A violation of Section 21(a) is alleged because evidence of open dumping of waste was reportedly observed by fire department personnel during firefighting activities.

Pursuant to Section 21(d)(1) of the Act, in relevant part, no person shall conduct any waste-storage, waste-treatment, or waste-disposal operation without a permit granted by the Agency or in violation of any conditions imposed by such permit, including periodic reports and full access to adequate records and the inspection of facilities, as may be necessary to assure compliance with this Act and with regulations and standards adopted there under.

A violation of Section 21(d)(1) is alleged because evidence that waste was disposed of and/or stored without a permit granted by the Agency was reportedly observed by fire department personnel during firefighting activities.

Pursuant to Section 21(d)(2) of the Act, no person shall conduct any waste-storage, waste-treatment, or waste-disposal operation in violation of any regulations or standards adopted by the Board under this Act.

A violation of Section 21(d)(2) is alleged because evidence that waste was disposed of and/or stored in a way that violates regulations and standards adopted by the Board was reportedly observed by fire department personnel during firefighting activities.

Pursuant to Section 21(e) of the Act, no person shall dispose, treat, store or abandon any waste, or transport any waste into this State for disposal, treatment, storage or abandonment, except at a site or facility which meets the requirements of this Act and of regulations and standards there under.

A violation of Section 21(e) is alleged because evidence that waste was disposed of and/or stored in a manner that does not meet the requirements of the Act was reportedly observed by fire department personnel during firefighting activities.

Pursuant to Section 21(p)(1) of the Act, no person shall cause or allow the open dumping of any waste in a manner which results in any of the following occurrences at the dump site...litter.

A violation of Section 21(p)(1) is alleged because evidence that open dumping of waste was caused or allowed to occur and resulted in litter deposition on site was reportedly observed by fire department personnel during firefighting activities.

Pursuant to Section 21(p)(3) of the Act, no person shall cause or allow the open dumping of any waste in a manner which results in any of the following occurrences at the dump site...open burning.

A violation of Section 21(p)(3) is alleged because evidence that open dumping of waste was caused or allowed to occur and resulted in open burning on site was reportedly observed by fire department personnel during firefighting activities.

Pursuant to Section 21(p)(7) of the Act, no person shall cause or allow the open dumping of any waste in a manner which results in any of the following occurrences at the dump site...clean construction and/or demolition debris as defined in Section 3.160(b) of this Act.

A violation of Section 21(p)(7) is alleged because evidence that the open dumping of waste was caused or allowed to occur and resulted in the deposition of clean construction and/or demolition debris on site was reportedly observed by fire department personnel during firefighting activities.

Pursuant to Section 55(a), (1) of the Act, no person shall cause or allow open dumping of any used or waste tire.

A violation of Section 55(a), (1) is alleged because evidence that waste tires were opendumped on the site **Pursuant to Section 55(a), (1) of the Act,** no person shall cause or allow open dumping of any used or waste tire.

A violation of Section 55(a), (1) is alleged because evidence that waste tires were open-dumped on the site was reportedly observed by fire department personnel during firefighting activities.

Pursuant to Section 55(a), (2) of the Act, no person shall cause or allow open burning of any used or waste tire.

A violation of Section 55(a), (2) is alleged because evidence that a waste tire was reportedly observed by fire department personnel during firefighting activities.



On April 25 at 20:08 our fire department was dispatched to 3628 Stare Rd for a first alarm along with Argenta. Enroute to the fire we could see black smoke billowing in the sky from our location of the intersection of county highway 24 and county highway 25. Upon arrival we found a substantial fire burning on the far east side of property where there was a substantial Pile of brush burning a long with what appeared to be a couch or box springs, a old door, a large garden tractor tire and some copper wire and some miscellaneous construction materials. Because the fire was too hard to reach and most of the material was burnt up we left the fire burn itself out. This is not the first time we have been called to this residence for illegal burns, and we are usually not very welcomed by the land owner.
