

HEARING OFFICER ORDER

On July 26, 2018, a telephonic status conference was held. Petitioner stated that the Village of Kirkland has recently passed an ordinance prohibiting the use of the well built in 1896, the well at issue. Petitioner stated that passing this ordinance restricting use resolves any issues with Section 14.2 of the Illinois Environmental Protection Act. Therefore, petitioner will file a motion to voluntarily dismiss the above-captioned petition on or before August 17, 2018.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on August 30, 2018, at 10:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. If, however, petitioner files its motion before the next status conference, the conference will be cancelled without further notice.

IT IS SO ORDERED.




