
HEARING OFFICER ORDER

On August 30, 2018, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that by order of June 21, 2018, the Board lifted the previously ordered stay and will allow the Agency to issue a modified permit.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including March 28, 2019.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on December 19, 2018, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
