### **HEARING OFFICER ORDER**

A prehearing conference was held on Thursday, November 8, 2018, to discuss procedures for the next hearing in this proceeding. Today, dates are set for the fourth hearing in this proceeding and a prehearing conference, before the hearing, to discuss procedures at the hearing. The first part of hearing on January 29, 2019, is scheduled for the Board and Hearing Officer to exclusively hear any additional testimony. The hearing will be continued to January 30, 2019, if additional testimony will be presented. The afternoon and early evening hours of January 29, 2019, will be devoted to hearing any additional oral public comment.

### Prefiled Testimony, Questions, and Answers

Participants agreed to deadlines for prefiling of testimony and questions for the January 29, 2019, hearing. The deadline to prefile testimony with the Board is 4:30 p.m. on December 10, 2018. Prefiled questions, based upon the prefiled testimony, must be filed with the Board by 4:30 p.m. on January 7, 2019. If participants wish to prefile answers, those answers must be prefiled by 4:30 p.m. on January 23, 2019.

The procedure for this fourth hearing will be for the Board to hear prefiled testimony until 4:00 p.m. on January 29, 2019. The Board will accept public comment on the record from 5:30 p.m. to 8:00 p.m. on January 29, 2019. If additional testimony remains to be heard, the Board will resume the hearing on January 30, 2019, to exclusively hear this remaining testimony.

#### Procedures for Offering Public Comment

Interested persons who wish to offer oral public comment on January 29, 2019, should email the hearing officer by 5:00 p.m. on January 3, 2019. If the commenter is unavailable during evening hours, the individual should indicate this unavailability in the request to offer comments.

The hearing officer will place a sign-up sheet at the back of the hearing room on January 29, 2019, and persons will be allowed to sign-up to offer oral public comment to the Board until 6:30 p.m. Persons who wish to sign up on January 29, must sign up for themselves.

The time allowed for each commenter will be limited based upon the number of persons who sign-up to speak. The hearing on January 29 will end at 8 p.m., even if individuals are present who could not offer oral comments to the Board. The Board will not continue the hearing to January 30, 2019 for purposes of public comment.

#### Written Public Comment

Written public comments bear the same weight as oral public comments. Written public comment may be filed with the Board at any time until the conclusion of the comment period. This date will be announced by hearing officer order after the close of hearings. If you have any

questions regarding written public comment, you may contact the hearing officer or the Clerk of the Board.
