**AGREED MOTION TO DISMISS**

Defendant, Flood Brothers Disposal Co. d/b/a Flood Brothers Disposal & Recycling Services, by its attorneys SAUL EWING ARNSTEIN & LEHR LLP, respectfully moves the board for an entry dismissing this complaint, in its entirety, without prejudice stating as follows:

1. On November 7, 2018 Steven Brison filed a complaint against Flood Brothers captioned *Steven Brison v. Flood Brothers Disposal Co. d/b/a Flood Brothers Disposal & Recycling Services; Flood Brothers Disposal/Recycling Services, an Illinois Corporation*, before the Illinois Pollution Control Board, Case No. PCB 20.

2. Subsequently, on January 3, 2019 the parties entered into a settlement agreement resolving all matters and controversies between the parties.

WHEREFORE, Flood Brothers prays that the board enter an order dismissing this complaint, in its entirety, without prejudice subject to reinstatement in the event Flood Brothers violates the settlement agreement.


