MOTION FOR VOLUNTARY DISMISSAL

Petitioners, Rockford Power, LLC and Rockford Power II, LLC, by and through its attorneys, Sidley Austin LLP, hereby move the Illinois Pollution Control Board (the Board) to dismiss this action. In support of its motion, Petitioners state as follows:

1. On October 29, 2014, Petitioners (through predecessors and former petitioners NRG Rockford LLC and NRG Rockford II LLC) filed a Petition for Review of CAAPP Permit and Motion for Stay requesting review of the Clean Air Act Permit Program (“CAAPP”) permit I.D. No. 201030BCG issued by the Illinois Environmental Protection Agency (“Agency”) on September 25, 2014 (the “CAAPP Permit”).
2. On November 6, 2014 and November 20, 2014, the Board entered orders accepting the Petition for hearing and granting the Petitioners’ request for stay of the contested permit conditions, respectively.
3. Subsequently, Rockford Power, LLC and Rockford Power II, LLC and the Agency have engaged in negotiations regarding the CAAPP Permit and resolved the issues raised in the Petition. Pursuant to these negotiations, Petitioners submitted an application to modify the CAAPP Permit and the Agency issued a revised permit on November 20, 2018.

4. Rockford Power, LLC and Rockford Power II, LLC request that the Board dismiss this matter and close the docket.

5. Counsel for the Agency does not object to this motion.
