The current proposal we are discussing tonight is better than Governor Rauner's original proposal, but it still is unacceptable to me and many other public health organizations. I join them in urging you to leave current Multi-Pollutant Standards in place and I'd like to tell you why.

I'm old enough to remember what air quality was like in America during the late 50's and early 60's. In those days, often the sides of buildings in our cities were blackened with soot from coal fired power plants.

And thanks to the creation of the EPA and regulations like the current Illinois Multi-Pollutant Standard, we have made improvements to air quality over the last several decades. But recent news reports have noted that improvements to air quality in the US are slowing down significantly.

And even though the last 60 years have seen an improvement in air quality for some of us, there are many areas of our State where residents today have to breath air that is still unhealthy-simply because they live near coal-fired power plants. Often those most impacted by coal fired power plant pollution are poor people or people of color. It is not acceptable to harm these communities this way. I speak in particular of people in the Peoria/ Pekin area and others in which asthma rates are notably higher due to coal-fired power plant emissions. For these people, the gains of the past 60 years have not made much of a difference. In truth, our work to make air healthy for ALL Illinois residents is not over.

It is in solidarity with people in Illinois currently breathing unhealthy air that I urge you to leave the current Multi-Pollutant Standard in place. The proposal before us tonight, if approved, allows Dynergy-Vistra to increase its dangerous coal pollution by 40%, further degrading the air quality of people who live in communities already at risk for unhealthy air.
