**RESPONDENTS' COMMUNITY LANDFILL COMPANY AND THE CITY OF  
MORRIS' JOINT RESPONSE TO COMPLAINANT'S MOTION TO SET  
EXPEDITED HEARING DATE**

Respondents COMMUNITY LANDFILL COMPANY and THE CITY OF MORRIS hereby jointly respond to the Complainant, PEOPLE OF THE STATE OF ILLINOIS' Motion to Set Expedited Hearing Date, and in support thereof, state as follows:

**PROCEDURAL HISTORY**

1. On April 16, 2003, Complainant People of the State of Illinois ("Complainant" or "People") filed a One-Count complaint against Respondents Community Landfill Company and the City of Morris ("Respondents", collectively, or "CLC" or "City", individually) alleging violations of 35 Ill. Adm. Code 800.700(f) and 800.712(b) resulting in violation of Section 21(d)(2) of the Illinois Environmental Protection Act ("the Act").


2. Complainant filed a Motion for Summary Judgment on July 21, 2005 to which Respondents appropriately and timely filed its responses and/or cross-motions and/or motion to strike. The Board's Order concerning the parties' various motions is dated February 16, 2006.

"imperative" that the parties "complete the hearing process as soon as possible" and "provide the Board with the requested information". This is a complete mischaracterization of the process. The Board did not "request" information in its Order. Rather, it directed the parties to proceed to hearing on certain issues, if appropriate. (Order, p. 16).

### CONCLUSION




