RESOLUTION AND ORDER OF THE BOARD (by Mr. Dumelle):

On December 14, 1978 the Board invoked the provisions of Section 9.1 of the Act and adopted a new Part IX of Chapter 2: Air Pollution governing New Source Performance Standards and a new Part X governing Emission Standards for Hazardous Air Pollutants.

Since that time the Administrator of the United States Environmental Protection Agency has promulgated the following additional rules and amendments to existing rules in Parts 60 and 61 of Title 40 of the Code of Federal Regulations:

- 1). January 12, 1979 (44 Federal Register 2579) Amendments to Appendix A - Reference Methods of Part 60;
- 2). March 12, 1979 (44 Federal Register 13480) Amendments to Definitions in Subpart J of Part 60;
- 3). June 11, 1979 (44 Federal Register 33580) Promulgation of New Source Performance Standards for Electric Generating Units by amendments to Subparts A and D, the inclusion of a new Subpart D a, and the addition of Method 19 to Appendix A - Reference Methods of Part 60;
- 4). September 10, 1979 (44 Federal Register) 52792 Promulgation of New Source Performance Standards for Gas Turbines by the inclusion of a new Subpart GG and the addition of Method 20 to Appendix A - Reference Methods in Part 60;
- 5). September 25, 1979 (44 Federal Register 55173) Amendments to Definitions in Subpart A of Part 60;
- 6). September 25, 1979 (44 Federal Register 55174) Amendments to Definitions in Subpart A of Part 61;  
and
- 7). October 25, 1979 (44 Federal Register 61542) Amendments to the New Source Performance Standards for Petroleum Refinery Claus Sulfur Recovery Plants with a processing capacity over 20 long tons per day (LTD) by an amendment to Subpart J of Part 60.


The Board hereby adopts the above noted amendments to Part 60 of Title 40 of the Code of Federal Regulations as amendments to Part IX of Chapter 2: Air Pollution.

The Board hereby adopts the above noted amendments to Part 61 of Title 40 of the Code of Federal Regulations as amendments to Part X of Chapter 2: Air Pollution.
