

HEARING OFFICER ORDER

On June 15, 2006, all parties participated in a telephonic status conference with the hearing officer. The petitioner represented that it has forwarded all of the documents in question to the United States Environmental Protection Agency (USEPA) as requested by the USEPA. The petitioner represented that it will file a six month waiver of the statutory decision deadline.

IT IS SO ORDERED.




