NOTICE OF WAIVER OF 120-DAY DECISION DEADLINE FOR AN ADDITIONAL NINETY DAYS

("Petitioner"), by and through its attorneys, HODGE DWYER ZEMAN, pursuant to 35

Ill. Admin. Code § 101.308(c)(2), and hereby agrees to waive the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board ("Board"), in the above-referenced proceeding, for an additional 90 days, or until May 16, 2007. In support of this Notice, the Petitioner states as follows:

- 1.
