

HEARING OFFICER ORDER

On March 29, 2007, all parties participated in a telephonic status conference with the hearing officer. The parties represented that a stipulation and proposal for settlement (stipulation) is being circulated for review. By agreement, respondents' answer is now due to be filed on or before June 15, 2007.

At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further order.

IT IS SO ORDERED.




