R07-18	<u>In the Matter of : Nitrogen Oxide (NOx) Emissions From Stationary Reciprocating Internal Combustion Engines and Turbines: Amendments to 35 Ill. Adm. Code Section 201.146, Parts 211 and 217</u> – The Board found that part of the Illinois Environmental Protection Agency’s April 6, 2007 proposal is not “required to be adopted” by the Clean Air Act. Accordingly, the Board bifurcated this proposal by continuing to consider the portion applicable to the 28 internal combustion engines affected by the nitrogen oxides State Implementation Plan Call Phase II under Section 28.5 of the Act (415 ILCS 5/28.5 (2004)) in docket R07-18. The Board opened R07-19 and will consider the remainder of the proposal in that separate docket under Section 27 of the Act (415 ILCS 5/27 (2004)).	4-0 R, Air
