

**HEARING OFFICER ORDER**

On July 12, 2007, telephonic status conference was held with the hearing officer. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a motion to voluntarily dismiss is filed prior to the next status conference, the conference will be cancelled without further order.

IT IS SO ORDERED.




