After reviewing the Board's Opinion and Order dated July 26, 2007, the following errors were found:

- Initial distribution system evaluation should cite to 141.601(b), which is the federal cite instead of 611.921(b).
- "Wellhead protection area" must cite to 17.2 instead of 17.1. There are two locations were 17.1 was incorrectly cited.
- On page 107 of the Order, 611.801(b), line 3, replace "or" with "of" [...within the WHPAs and evaluation of the...]
