Dear Mr. & Mrs. Lo:

On March 22, 2007 and April 3, 2007, the above referenced site was inspected by Mike Mullins of the Illinois Environmental Protection Agency. The purpose of these inspections was to determine compliance with the Illinois Environmental Protection Act (Act) and 35 Illinois Administrative Code; Subtitle G: Land Pollution Regulations. At the time of these inspections, apparent violations found during in a previous inspection conducted on January 16, 2007 were again observed.

It is emphasized that all waste (the refuse open dumped on site and the demolition debris) must be properly disposed at a landfill or transfer station permitted by this Agency. None of this waste is to be burned. If local ordinances allow, the only material that can be burned, is the on site generated landscape waste, if it is totally separated from all other waste. As the demolition debris from the house may contain asbestos, this debris should be wetted and transported in a covered container or truck. The landfill must also be informed that the debris may include asbestos containing material. It is our understanding that as of April 12, 2007, three loads of demolition debris have been hauled from the site.

On May 2, 2007 a re-inspection of your facility was conducted by Mike Mullins of the Illinois Environmental Protection Agency. The purpose of this re-inspection was to determine your compliance status with respect to the apparent violations cited in the Agency's February 16, 2007 and April 16, 2007 letters. During the re-inspection it was determined that your facility has returned to compliance with the apparent violations 9(a), 9(c), 21(a), 21(d)(1), 21(d)(2), 21(e), 21(p)(1), 21(p)(3), and 21(p)(7) of Illinois Environmental Protection Act and 812.101(a) of Title 35 Illinois Administrative Code, Subtitle G: Land Pollution (Regulations).

Please note, although you have returned to compliance for these apparent violations, the Agency reserves the right to pursue further enforcement. This letter only applies to your site located at 1255 County Road 200E near Seymour, Illinois
