On September 24, 2007, the parties participated in a telephone status conference with the hearing officer. The parties are discussing the possibility of settlement, but petitioner did not agree to waive the decision deadline. Accordingly, a hearing was set for October 30-31, 2007. To cancel the hearing, petitioner must file a deadline waiver to March 20, 2008 or later, or a motion to voluntarily to dismiss at least 24 hours before hearing.

The parties are directed to participate in a telephone status conference with the hearing officer at 2:00 p.m. on October 23, 2007. The status conference shall be initiated by the petitioner.

The decision deadline is December 20, 2007.
