**AGREED MOTION OF RESPONDENT, PLASTIC CAPACITORS, INC.
FOR EXTENSION OF TIME TO FILE ANSWER OR OTHERWISE PLEAD**

Respondent, Plastic Capacitors, Inc. ("Respondent"), by and through its attorneys, Deutsch, Levy & Engel, Chartered, moves the Illinois Pollution Control Board (the "Board") to grant an extension of time of an additional sixty (60) days pursuant to 35 Ill. Adm. Code Section 101.522, from September 28, 2007 to November 27, 2007, in which to file its answer or otherwise plead. In support thereof, Respondent states as follows:

1. On July 30, 2007, Complainant filed its Complaint in this matter.
2. Pursuant to 35 Ill. Adm. Code Section 103.204(d), Respondent's answer is due to be filed on or by September 28, 2007.
3. Respondent requests the Board to grant it an extension of the deadline to file its answer or otherwise plead, because Respondent is in active settlement discussions with the Illinois Attorney General's Office. If said discussions are fruitful, settlement of this matter is very likely.
4. Accordingly, Respondent respectfully requests that the Board grant an extension of time to file its answer or otherwise plead in this matter from September 28, 2007 to November 27, 2007.

5. Counsel for Respondent has spoken to, Assistant Attorney General Zemeheret Bereket-Ab, counsel for Complainant, who has confirmed that he has no objections to such extension.

6. This request is made in good faith and with the intent to preserve the valuable resources of the Board, as well as of the parties hereto.

WHEREFORE, Respondent, Plastic Capacitors, Inc., respectfully requests that the Board to grant an extension of time of an additional sixty (60) days, from September 28, 2007 to November 27, 2007, in which to file its answer or otherwise plead.
