#### ADMINISTRATIVE RECORD

The Respondent, Illinois Environmental Protection Agency ("Illinois EPA"), by and through its attorneys and pursuant to the procedural requirements of the Illinois Pollution Control Board ("Board") set forth at 35 Ill. Adm. Code 105.212 and 105.116, files the Administrative Record of Permit Application ("Administrative Record") in this cause.

- 1. This matter originates from a state construction permit, Construction

  Permit No. 07060011, that was granted by the Illinois EPA to Midwest Generation on

  August 8, 2007, for the construction of a sorbent injection system to control mercury for
  the Unit 3 and Unit 4 boilers at the Will County Generating Station located in

  Romeoville, Illinois.
- 2. On or about September 6, 2007, Petitioner filed a petition with the Board seeking an appeal of the Illinois EPA's permitting decision. The Illinois EPA received an electronic copy of the appeal on September 5, 2007. Formal notice of the appeal was served on the Illinois EPA on September 10, 2007.

- On September 20, 2007, the Board accepted the case for hearing and, consistent with the Board's procedural rules, directed the Illinois EPA to file its
   Administrative Record by October 8, 2007.
