

AMENDED HEARING OFFICER ORDER

On January 24, 2008, a telephonic status conference was held with the hearing officer. By agreement between the parties, petitioner's reply to respondent's United City of Yorkville's response to petitioner's motion to compel and for sanctions is now due on or before January 31, 2008. The petitioner represented that it will file a waiver of the statutory decision deadline to and including July 24, 2008. The petitioner represented that it will file a motion to withdraw its request for sanctions.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on February 28, 2008, at 1:30 p.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. The petitioner represented that the conference call-in number will be the same as on January 24, 2008. At the conference the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


