### **REQUEST FOR NINETY DAY EXTENSION OF APPEAL PERIOD**

NOW COMES the Petitioner, Joyce Farms Recycling, Inc. ("Joyce Farms"), by and through its attorneys, Brown, Hay & Stephens, LLP, and, pursuant to Section 40(a)(1) of the Illinois Environmental Protection Act (415 ILCS 5/40(a)(1)) and 35 Ill. Adm. Code 105.208, hereby requests that the Illinois Pollution Control Board ("Board") grant an extension of the thirty-five (35) day period for petitioning for a hearing to June 2, 2008, or any other date not more than a total of one hundred twenty-five (125) days from the date of service of the Illinois Environmental Protection Agency's ("Illinois EPA") final decision.
