

HEARING OFFICER ORDER

On January 15, 2009, a telephonic status conference was held. The petitioners represented that discussions continue and progress has been achieved regarding a modified host agreement. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a motion to voluntarily dismiss is filed prior to the next status conference, the conference will be cancelled without further order.

IT IS SO ORDERED.




