SECOND NOTICE CHANGES

Agency: Pollution Control Board

Rulemaking: Water Quality Standards (35 Ill. Adm. Code 302; 31 Ill. Reg. 13624)

Changes:

1. Change lines 231-240 to:

"less than 3:1. In streams where the dilution ratio is less than 3:1, the volume in which mixing occurs, alone or in combination with other volumes of mixing, must not contain more than 50% of the volume flow unless an applicant for an NPDES permit demonstrates, pursuant to subsection (d) of this Section, that an adequate zone of passage is provided for pursuant to subsection (b)(6) of this Section. ~~Mixing is not allowed in receiving waters which have~~".

2. In the table following line 359, in the entries for "Cadmium" and "Lead", add parentheses around "H" each time it appears.
3. In line 418, change "above" to "in subsection (h)(3)(A) or (B)".
4. In line 419, change "Section" to lower case.
5. In line 421, change "C.F.R." to "CFR".
