

1. The Attorney General, on behalf of the People of the State of Illinois (“People”) served the Complaint on Aramark’s representative on or about August 3, 2009.
2. On September 16, 2009, the Attorney General filed its Motion to file its “First Amended Complaint.” That Motion has not yet been heard.
3. Counsel for Aramark contacted the Attorney General and requested an extension of time to answer or otherwise respond to the Complaint. The Attorney General’s Office agreed to an extension until November 20, 2009.


4. This case is currently set for a status conference at 2:00 p.m. on October 20, 2009.


