HEARING OFFICER ORDER



The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on December 10, 2009, at 1:00 p.m. The telephonic conference must be initiated by the complainants, but each party is nonetheless responsible for its own appearance. At the conference the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


