The Illinois EPA has reviewed the Board's order dated October 1, 2009, which contained the proposed rule. Having reviewed the Board's October 1 opinion and order, the Agency has no concerns or objections as to the format and the content of the proposed rule. Just for the clarity of the record, however, the Illinois EPA would note that there is a typographical error on page two of the October 1 Order. Just under the heading, “The Addition of a Newly Exempted Compound,” mention is made of a Federal Register dated “January 21, 2007.” The correct date of the Federal Register is “January 21, 2009.”
