

**HEARING OFFICER ORDER**

At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation and proposal for settlement is filed prior to the next status conference, the conference will be cancelled without further notice.

IT IS SO ORDERED.




