JURISDICTION

This Administrative Citation is issued pursuant to the authority vested in the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act, 415 ILCS 5/31.1 (2000).

FACTS

- 1. That Tony Luttrell is the present owner and operator of a facility located Northeast of Xenia at approximate coordinates 360N and 360E, in Clay County, Illinois. The property is commonly known to the Illinois Environmental Protection Agency as Xenia/Luttrell, Tony.
- 2. That said facility is an open dump operating without an Illinois Environmental Protection Agency Operating Permit and is designated with Site Code No. 0258115001.
 - 3. That Respondent have owned and operated said facility at all times pertinent hereto.
- 4. That on May 30, 2002, Kent Johnson of the Illinois Environmental Protection Agency's Marion Regional Office inspected the above-described facility. A copy of his inspection report setting forth the results of said inspection is attached hereto and made a part hereof.

VIOLATIONS

Based upon direct observations made by Kent Johnson during the course of his May 30, 2002 inspection of the above-named facility, the Illinois Environmental Protection Agency has determined that Respondent has violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

(1) That Respondent caused or allowed the open dumping of waste in a manner resulting in deposition of general construction or demolition debris or clean construction or demolition debris, a violation of Section 21(p)(7) of the Act, 415 ILCS 5/21(p)(7) (2000).

CIVIL PENALTY

On May 2, 2002, the Pollution Control Board found that Respondent had violated the provisions listed in an Administrative Citation filed on March 25, 2002 (PCB No. AC 02-48). Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5) (2000), for a second or subsequent offense Respondent is subject to a civil penalty of Three Thousand Dollars (\$3,000.00) for each of the violations identified above, for a total of <u>Three Thousand Dollars (\$3,000.00)</u>. If Respondent elects not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than <u>August 15, 2002</u>, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondent elects to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 (2000), and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondent shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the One Thousand Five Hundred Dollar (\$1,500.00) statutory civil penalty for each

violation.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1) (2000), if Respondent fails to petition or elects not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondent's check shall be made payable to the Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Along with payment, Respondent shall complete and return the enclosed Remittance Form to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondent from the date payment is due up to and including the date that payment is received. The Office of the Illinois Attorney General may be requested to initiate proceedings against Respondent in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

Respondent has the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31/1 (2000). If Respondent elects to contest this Administrative Citation, then Respondent shall file a signed Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago, Illinois 60601. A copy of said Petition for Review shall be filed with the Illinois Environmental Protection Agency's Division of Legal Counsel at 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondent.

Complaint Investigation Report Narrative

This unpermitted site was inspected on May 30, 2002 by this author representing the Agency. The investigation was conducted in response to a complaint alleging the improper disposal of waste from a house demolition in Flora, Illinois. Observations of the suspected demolition site were made from 3:05 to 4:42 P.M., while on-site observations were made from 5:00 to 5:12 P.M. Two photos were taken at the suspected demolition site {Photos 001-002}, and five photos were taken on-site {Photos 003-007}. Weather during the investigation ranged from rain in Flora at approximately 3:17 P.M. to mostly sunny at the time of the on-site observations. Air temperature was warm with a slight breeze throughout. Mrs. Luttrell was interviewed very briefly on this site prior to making on-site observations.

General Remarks

This site is located southwest of Xenia, Illinois. It is the apparent residence of Mr. and Mrs. Tony Luttrell, R.R. 2, Box 8; Xenia, IL 62899. Using county road coordinates, the site is located at roughly 125N and 210E on the east side of the road. The current area of concern sits behind the house. The Luttrells' phone number is 618/678-2798.

Inspection Findings

I arrived at the suspected demolition site in Flora, IL at approximately 3:05 P.M. At the site, which is located at the southwest corner of Locust and Maple Streets, I observed a pile of demolition debris, a trackhoe, and a green Ford pick-up (IL license # 3330 YU, B truck plate). I watched the site until a white International 10-wheel dump truck (IL license # 12 731, weight class D) arrived at the site at approximately 4:25 P.M. A man and a child got out of the dump truck, put what appeared to be a cooler in the pick-up, and left. I left the site shortly thereafter, taking a photo of the truck's license plate {Photo 001} and the debris {Photo 002} on my way out to Mr. Luttrell's residence.

I arrived at Mr. Luttrell's residence at approximately 5:00 P.M., noting smoke rising from behind the house. I drove into the driveway, and proceeded to knock on the front door; a woman who later identified herself as Mrs. Luttrell opened the door. I identified myself as well as the nature of the inspection, advising Mrs. Luttrell that I had observed smoke while approaching the site. Mrs. Luttrell said that her husband was just cleaning some stuff up. When I asked if she would

mind if I went back to take a look, she agreed, remaining in the house while I walked to the area of concern.

The area of concern was approximately 9' by 12', with smoldering waste protruding from what appeared to be very recently disturbed soil {Photos 003-004}. Waste observed in the area included demolition debris {Photos 005-007} and a bicycle rim {Photo 005}, some of which was in standing water {Photo 006}. At the back of the area, the walls of an excavated pit were estimated to be 3', yielding a total volume of 12 cubic yards for the area of concern (9' x 12' x 3', divided by 27 to convert to cubic yards).

After making physical observations of that area, I noted the presence of a dump truck (IL license plate # 50 603, H class). Just south of the area of concern, I noted a large pile of concrete. However, no evidence of any recent demolition was noted on the site. I left the site at approximately 5:12 P.M.

Summary of Inspection Findings

At the time of this inspection, a number of apparent violations were observed. Waste was apparently burned and buried, so air pollution and open dumping violations will be cited. Since waste was observed in standing water, water pollution violations will be noted. Finally, given that no evidence of on-site demolition was noted, violations will be noted for receiving waste from off-site without meeting the required permitting standards.

Violations of Sections 9(a), 9(c), and 21(p)(3) are being cited because waste has apparently been open dumped resulting in open burning at this site, which would tend to cause air pollution in Illinois.

Violations of Sections 12(a), 12(d), and 21(p)(4) are being cited because waste has apparently been open dumped in standing or flowing water, which would tend to cause water pollution in Illinois.

Violations of Sections 21(a), 21(p)(1), and 21(p)(7) are being cited because waste, including demolition debris, has apparently been open dumped resulting in litter at this site.

Violations of Sections 21(d)(1) and 812.101(a) are being cited because waste has apparently brought to this facility, which does not have a permit to receive waste, in addition to the fact that no application has apparently been submitted to that end.

Violations of Sections 21(d)(2) and 21(e) are being cited because violations of the [Illinois] Environmental Protection Act and 35 Ill. Adm. Code were observed at the time of the inspection.






