NOTICE OF WAIVER OF 120-DAY DECISION DEADLINE FOR AN ADDITIONAL SIXTY (60) DAYS

NOW COMES Petitioner, EXXONMOBIL OIL CORPORATION ("Petitioner"), by and through its attorneys, HODGE DWYER & DRIVER, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), and hereby agrees to waive the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board ("Board") in this proceeding for an additional sixty (60) days, or until August 3, 2010. In support of this Notice, Petitioner states as follows:

- 1. On November 4, 2009, Petitioner filed a Petition for Review of Agency
 NPDES Permit Decision ("Petition") regarding the National Pollutant Discharge
 Elimination System Permit that was reissued to Petitioner on September 30, 2009, by the
 Illinois Environmental Protection Agency ("Agency"), for Petitioner's petroleum refinery
 located at I-55 and Arsenal Road in Channahon Township in unincorporated Will
 County, Illinois. Petitioner also filed a Motion to Stay the Effectiveness of Contested
 Permit Conditions simultaneously therewith.
- 2. On November 19, 2009, the Board accepted the Petition for hearing, but reserved "ruling on stay issues until the Agency has filed a response or the response time

has elapsed." Board Order, *ExxonMobil Oil Corporation v. Illinois EPA*, PCB No. 10-30 (Ill.Pol.Control.Bd. Nov. 19, 2009).

- 3. On December 14, 2009, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline for an Additional Ninety (90) Days, agreeing to waive the decision deadline until June 4, 2010, which is the current statutory deadline.
- 4. Petitioner hereby voluntarily agrees to waive the statutory 120-day decision deadline for an additional sixty (60) days, or until August 3, 2010, in order to conduct settlement negotiations in this matter.

WHEREFORE, Petitioner, EXXONMOBIL OIL CORPORATION, prays that the Illinois Pollution Control Board accept this waiver of the statutory 120-day decision deadline for final action on Petitioner's appeal of the National Pollutant Discharge Elimination System Permit reissued to it by the Illinois Environmental Protection Agency.
