

**HEARING OFFICER ORDER**

On May 12, 2010, all parties appeared for a telephonic status conference with the hearing officer. The parties stated that they are still on track for a settlement in this matter and anticipate filing a stipulation and proposal for settlement (stipulation) pursuant to Section 103.301 and 103.302 of the Board's procedural rules.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on June 24, 2010, at 1:00 p.m. The telephonic conference must be initiated by the complainant, but each party is nonetheless responsible for their own appearance. At the conference, the parties must be prepared to discuss the status of the settlement discussions. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further notice.

IT IS SO ORDERED.




