MOTION OF RESPONDENTS CHEVRON U.S.A. INC. AND TEXACO INC. FOR CLARIFICATION OF ORDER OF JUNE 3, 2010

Respondents, Chevron U.S.A. Inc., incorrectly named as Chevron U.S.A., Inc., and Texaco Inc. (collectively "Respondents"), by their attorneys Henderson & Lyman, request, for the reasons set forth below, that the Illinois Pollution Control Board ("Board) clarify its order of June 3, 2010.

- 1. On April 21, 2010 Complainants filed a motion for leave to file an amended complaint which, <u>inter alia</u>, adds Texaco Inc. as a respondent. The motion also requested that the Board deem the amended complaint filed.
- 2. On June 3, 2010 the Board issued an order finding that Complainants had not yet demonstrated service of the amended complaint on Texaco Inc. and ordered Complainants to file a proof of service on Texaco Inc. on or before June 17, 2010. See Exhibit 1 attached.
 - 3. Respondents have been served with the amended complaint and Complainants

have filed a proof of service indicating service on Respondents on June 11, 2010.

- 4. Respondents intend, and are presently prepared, to file a response to the amended complaint pursuant to 35 Ill. Adm. Code 212(b). The order of June 3, 2010, however, did not state whether or not Complainants' motion was granted or denied, whether or not Complainants are allowed to file the amended complaint, whether the amended complaint is deemed filed and what the date of filing is, or whether the Board intends to review and further rule on the motion after Complainants filed the proof of service.
- 5. In light of the language of the order Respondents cannot determine if or should the 30-day period under Section 212(b) begin to run from the date of service of the amended complaint, being June 11, 2010, or from some other date.

Wherefore, Respondents request that the Board clarify the order of June 3, 2010 in respect to whether or not the motion is granted, whether or not the amended complaint is deemed filed and when a response from Respondents under 35 Ill. Adm. Code 212(b) would be due.
