**MOTION FOR EXTENTION OF TIME AND LEAVE TO FILE
A REDUCED NUMBER OF COPIES OF THE RECORD**

Respondent DeKalb County Board (County), by its attorneys, Renee Cipriano and Amy Antonioli of Schiff Hardin, LLP, moves the Board or the Hearing Officer for an extension of time to file the record and for leave to file a reduced number of copies of the record of proceedings.

1. On June 21, 2010, the Illinois Pollution Control Board (Board) issued an order accepting the petitions of Stop the Mega-Dump and Waste Management of Illinois, Inc. (WMII), for hearing and consolidating those petitions on its own motion for the purposes of hearing.

Electronic Filing - Received, Clerk's Office, July 2, 2010

2. That order also directed the County to file the record of proceedings within 21 days, or by July 8, 2010.

3. In a landfill siting appeal, the Board's procedural rules require the local siting authority to file seven copies of the transcript and one original and 9 copies of all other documents in the record with the Board. 35 Ill. Adm. Code 107.304(c).

4. Because the record of proceedings is so voluminous, and because the number of Board members has been reduced since the effective date of the current filing requirements, the County seeks leave to file an original hard copy of the record of proceedings along with two (2) set of discs containing an electronic version of the record.

5. During the June 29, 2010 status call with Hearing Officer Halloran, WMII orally indicated it would file a motion to sever the above-captioned proceedings. On July 2, 2010, the County received such motion.

6. The County seeks an extension of time to file the record to allow the Board or Hearing Officer to consider the County's motion to file a reduced number of copies of the record along with WMII's motion to sever.

WHEREFORE, the DeKalb County Board moves the Board or the Hearing Officer for an extension of time to file the record and for leave to file a reduced number of copies of the record of proceedings.


